- Use rate is 1 gallon/acre, applied as a soil drench or in irrigation. Apply product regularly at 0.5 gallon/acre to 2 gallons/acre any time fertilizer is used, or every 15-30 days.
- Broadcast: 1 gallon/acre
- Can be applied with fertilizers or alone on a regular interval throughout the crop cycle.
